

4.0 BOARD OF TRUSTEES

4.1(a) ; The management and control of the trust and the properties of the trust shall vest in the board of the trustees. The board of trustees shall comprise not less than Two and not more than Eleven Trustees excluding the Settler Trustee. The following shall be the members of the First board of Trustees.

[2] Smt. Kalpana Santhalia, W/o Sri Manoj Kumar Santhalia at Gandhi Nagar, Kahalgaon, Bhagalpur, Bihar.

[3] Smt. Shailja Jhunjhunwala, W/o Sri Sandip Jhunjhunwala, of Tulsyan Sadan, Ghanta ghar chowk, Bhagalpur, Bihar.

[4] Smt. Shushila Devi Santhalia, W/o Late Om Prakash Santhalia, Purani Bazar, Kahalgaon, Bhagalpur, Bihar.

That the school will ensure compliance of all statutory requirements like EPF, ESI and labour laws etc. with respect to the school and staff of the school.



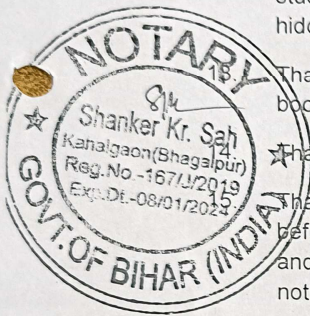
